COUNCILPERSON Moved the Following Ordinance:

SECTION I: Job Announcement Policy.

The City of Paterson shall post all job announcements generated by the Division of Personnel on the City of Paterson website prior to disseminating same in any other fashion. This ordinance shall be read in conjunction with and is not intended to supersede New Jersey law or regulations including but not limited to regulations or statutes governing classified positions.

SECTION II: If any part of this Ordinance shall be declared to be invalid or inoperative, such part shall be deemed severable and the invalidity thereof shall not affect the remaining parts of this Ordinance.

SECTION III: The City Clerk shall have this Ordinance codified and incorporated in the official copies of the Paterson Code.

SECTION IV: This Ordinance shall take effect upon passage, approval and publication, as required by law.

SECTION V: The City Clerk and Corporation Counsel may change chapter numbers, article numbers and section numbers if codification of this Ordinance reveals a conflict between those numbers and the existing Code, in order to avoid confusion and possible accidental repealers of existing provisions.

SECTION VI: The City Clerk and Corporation Counsel may correct clerical errors in the printing, publication and codification of this Ordinance, provided both concur with the correction and certify in writing to the Municipal Council that such correction is made within seven days thereof.
